Haryana Rail Infrastructure Development Corporation Limited (HRIDC), an implementing agency, for Haryana Orbital Rail Corridor (HORC) Project having its office at IRCON Tower-2, Plot No. 16, Sector-32, Gurugram, Haryana-122018, invites online Bids through e-Tender portal of Govt. of Haryana from eligible Bidders for the works of “**Composite Works Contract for Design and Construction of Station Building, balance works of IMD Building, Electrical, S&T and track maintenance office S&T huts, station approach roads including General Electrical Services and other associated works at Manesar in connection with laying of New BG Double Railway Line of Haryana Orbital Rail Corridor (HORC) Project.**” fulfilling the qualification criteria as mentioned in the Bid Document. The completion period of work is **548 days**. Bidders are advised to refer the Clauses on Eligibility (Section I-ITB, Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria) given in Vol I of Bid Document, to qualify for the participation in the Bid.
2. Bidding will be conducted through National Competitive Bidding (NCB) and is open to all eligible Bidders.
3. Interested eligible Bidders may obtain further information from the office of Chief Project Manager (West), HRIDC and inspect the Bid Document during office hours from 0930 to 1800 hours at the address given below:

4. The Bid Document in English will be available online on eProcurement portal of Govt. of Haryana (<https://etenders.hry.nic.in>) from **06.02.2025 at 0900 hrs. IST** till **18.03.2025 at 1500 hrs. IST**. The start date of submission of Bid on eProcurement portal is **11.03.2025 at 1100 hrs. IST**. Bidder is required to submit a non-refundable **E-Service fee of INR 1180.00** and Cost of Bid Documents of **INR 15,000.00** as indicated in the table at the end of this IFB. The method of payment of E-Service fee will be online in the eProcurement portal using the electronic payment gateway service. Bidders will be required to register in the above website.
5. For submission of the Bids, the Bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities (CAs), authorized by Government of India for issuing DSC. Bidders can see the list of licensed CAs from the link (www.cca.gov.in). Aspiring Bidders who have not

obtained the user ID and password for participating in eProcurement in this Project, may obtain the same from the website: <https://etenders.hry.nic.in>.

6. Bid comprise two Parts, namely the Technical Bid and the Price Bid, and both bids must be simultaneously submitted online on eProcurement portal (<https://etenders.hry.nic.in>) on or before **18.03.2025 at 1500 hrs. IST**. Bid validity shall be **180 days** after the last date of submission of Bids. Any Bid or modifications to Bid received outside eProcurement system will not be considered. The electronic Bidding system would not allow any late submission of Bids. The Technical Bid will be opened online on **18.03.2025 at 1530 hrs. IST** and this could be viewed by the Bidders online on eProcurement Portal. The Price Bid shall remain in encrypted form in the eProcurement system until the opening. If the office happens to be closed on the date of opening of the Bids as specified, the Bids will be opened on the next working day at the same time and venue.
7. All Bids must be accompanied by a Bid Security of the amount in the currency specified for the work in the table at the end of this IFB. Bid Security can be paid online on eProcurement Portal in INR in favour of Haryana Rail Infrastructure Development Corporation Limited using the electronic payment gateway service.
8. There will be no **Pre-Bid Meeting** for this Bid. Bidders are advised to download the Bid Document and may request any clarification on Bid Documents. Last date for submission of Bid queries for any clarification to the Employer is **21.02.2025 by 1800 hrs. IST** after which no queries will be acknowledged.
9. Other details can be seen in the Bid Document. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the Bidders of any updates, the Employer shall not be liable for any information not received by the Bidder.
